CANCELLATION OF SHARES AND TOTAL VOTING RIGHTS**

TORONTO, April 1, 2015 – For the purposes of the Financial Conduct Authority’s Disclosure and Transparency rules, Canaccord Genuity Group Inc. (the “Company”) (TSX: CF, LSE: CF.) announces that the total number of common shares in issue as at March 31, 2015, is 102,607,705, with each share carrying the right to one vote. This total may therefore be used by shareholders in the Company as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change in their interest in, the share capital of the Company under the FCA’s Disclosure and Transparency Rules.

Accounted for in this total number of common shares in issue is the cancellation as at March 31, 2015, of 182,988 common shares acquired by wholly-owned subsidiaries from former employees in accordance with pre-existing contractual arrangements.
