



**CANACCORD GENUITY GROUP INC. DISCLOSES
TRANSACTION IN OWN SHARES UNDER
NORMAL COURSE ISSUER BID/BUY-BACK PROGRAMME**

TORONTO, September 21, 2015 – Canaccord Genuity Group Inc. (the “Company”) (TSX: CF, LSE: CF.) wishes to announce that for the period of September 14, 2015, to September 18, 2015, it purchased 25,000 of its common shares through the facilities of the TSX and alternative trading systems pursuant to the normal course issuer bid (NCIB)/buy-back programme announced on August 10, 2015.

The highest and lowest daily average price paid for the purchased shares was \$5.8746 and \$5.4742 per common share respectively and the volume weighted average price per common share was \$5.6853.

The Company has purchased 193,267 common shares under the NCIB/buy-back programme which authorizes it to purchase up to 5,163,736 of its common shares between August 13, 2015 and August 12, 2016. Of these shares, 117,567 have been cancelled and the remaining 75,700 shares will be held in treasury until they are cancelled within the next 60 days.
